Gender-affirming procedures

This update applies to commercial members only.

We require prior authorization for all services for Gender-Affirming procedures. Use these forms:

- Gender-Affirming Surgery Precertification Information Request — Form GR-6995-2
- Gender-Affirming Hair Removal Authorization Request Form GR-69647

Also, we now have authorization forms for Gender-Affirming Hair Removal.

Submitting precertification requests

Changes to our National Precertification List (NPL)

This update applies to both our commercial and Medicare members.

The following new-to-market drugs require precertification:

- Skyrizi® IV (risankizumab-rzaa) precertification is required starting September 12, 2022. This drug is part of the Immunologic Agents drug category.
- Amvuttra[™] (vutrisiran) precertification is required starting September 22, 2022. This drug is part of the Hereditary Transthyretin-Mediated Amyloidosis (ATTR) drug category.
- Fylnetra® (pegfilgrastim-pbbk) precertification is required starting October 25, 2022. This drug is part of the Granulocyte Colony-Stimulating Factor drug category.

Be sure to submit precertification requests at least two weeks in advance. To save time, request precertification online. Doing so is fast, secure and simple.


